Legrand signs share buyback agreement

As part of its share buyback program¹, and under the authorization granted by the Ordinary and Extraordinary General Meeting of Shareholders of May 31, 2023², Legrand today announced the signing of a contract with an investment services provider to implement a second tranche for up to €80m.

The purchase period agreement is expected to begin on June 12, 2023 and end on or before July 21, 2023. Those shares will be cancelled.
